## GENERAL INFORMATION

Rebuilders Automotive Supply (RAS) is the exclusive buyback partner of non-deployed defective Takata airbags for Acura, Ford, GMC, Honda, Jaguar, Land Rover, Lexus, Lincoln, Mazda, Mercury, Mitsubishi, Pontiac, Saab, Scion, Subaru, and Toyota.

Not all vehicles listed are eligible for the buyback. Vehicles need to be validated by their VIN.

### Vehicles and VIN's:

1. The vehicles listed in the table are a range of years and models affected
2. You must run each VIN to determine whether the airbags are validated for that vehicle

4. The VIN's must be pre-authorized by RAS prior to receiving a PO (Purchase Order) and shipping documents

### Packaging

1. Only one airbag per box. You must include the printed VIN sheet with the airbag matching that VIN
2. Each airbag must be placed in a pink anti-static bag and cinched with a cable tie

### Hazards of Defective Takata Airbags:

As Toyota and NHTSA have publicly advised, in certain vehicles, the passenger and/or driver frontal airbag inflator could produce excessive internal pressure. If an affected airbag deploys, the increased internal pressure may cause the inflator to rupture. In the event of an inflator rupture, metal fragments could be propelled upward toward the windshield, or downward toward the front foot well, potentially causing injury or fatality to vehicle occupants.

### It is Illegal to sell Recalled Parts:

The FAST Act, Public Law 114-94, Section 24110 increases the maximum civil penalty to \$21,000 for each violation with the maximum that NHTSA can collect for a related series of violations to \$105 million.
